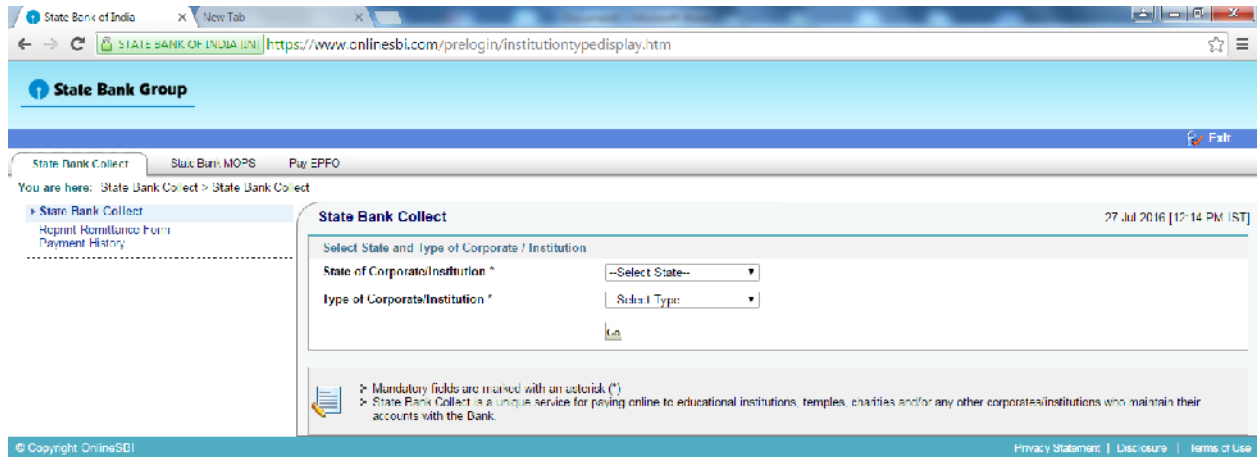

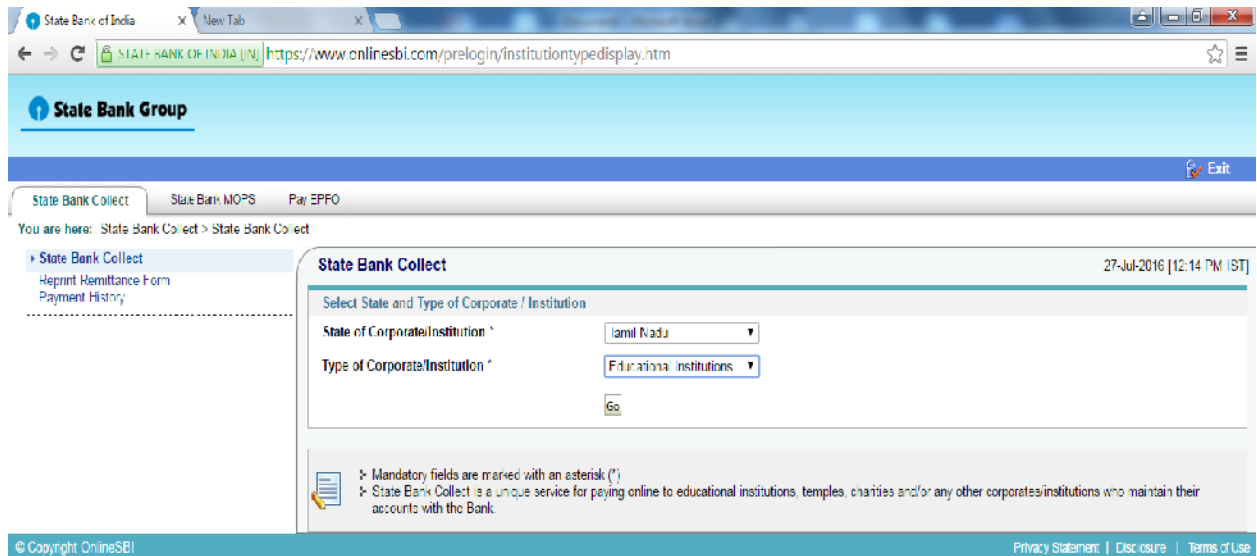

Click PROCEED Button



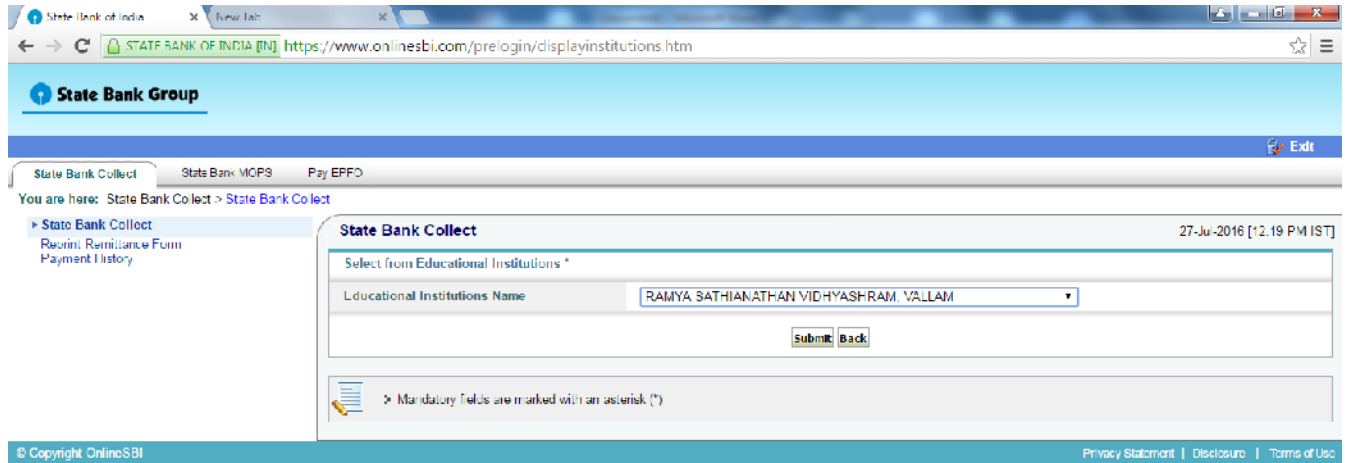
### STEP: 4

Select State "TAMILNADU" and "EDUCATIONAL INSTITUTIONS" in the appeared tab



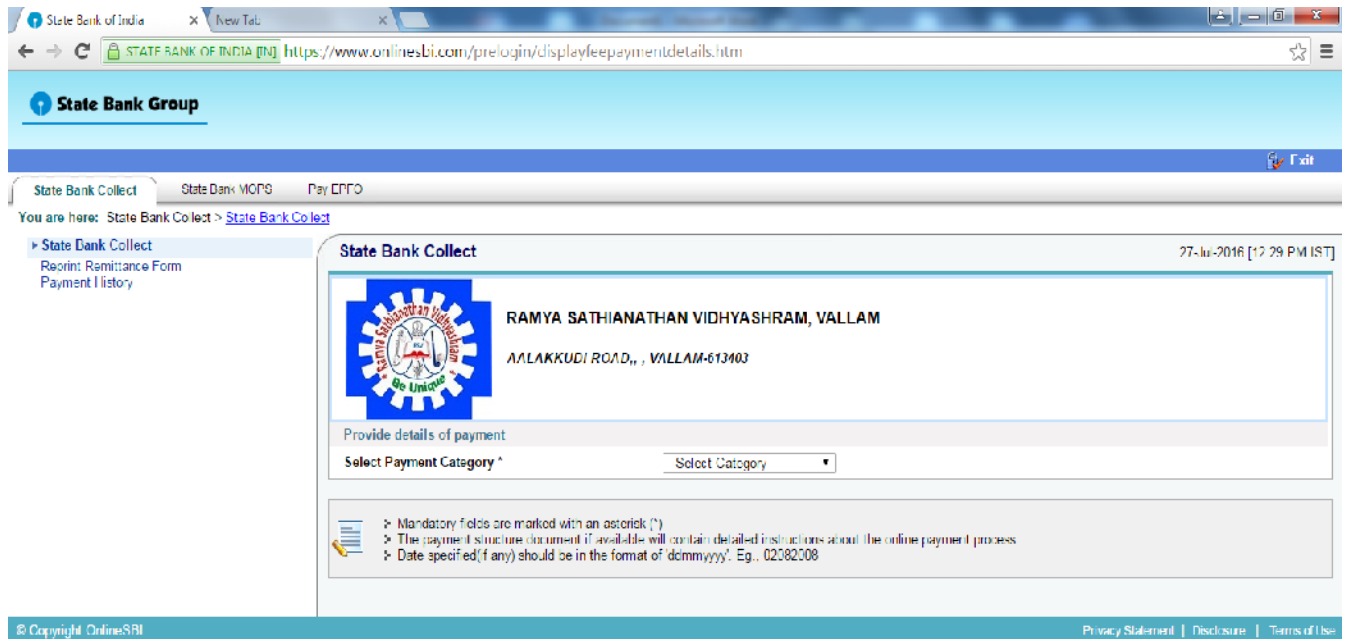
**STEP: 5**
